## NYRA 2023 Showdown Contest OFFICIAL RULES NO PURCHASE NECESSARY TO ENTER OR WIN.

**THE CONTEST:** The Showdown is a series of daily or months long mythical handicapping contests (each, a "Contest") taking place on live racing days during the 2023 race meetings at Aqueduct, Belmont Park, Belmont at the Big A or Saratoga (each, a "Contest Day"). Please submit any questions regarding the Showdown series, a Contest, or these Official Rules via email to Showdown@nyrainc.com.

**ELIGIBILITY:** Open to legal residents of the continental United States, 18 or older. Employees of The New York Racing Association, Inc. ("Sponsor"), NYRAbets, LLC ("NYRA Bets"), and their respective parents, subsidiaries, affiliates, advertising agents and promotional partners, and their immediate families (parent, child, spouse or sibling and their respective spouses, regardless of where they reside) and those living in their same households, whether or not related, of such individuals are not eligible to enter or win. By participating, entrants agree to be bound by these Official Rules and the decisions of Sponsor, which are binding and final on matters relating to this contest. Contest is subject to all applicable federal, state and local laws and regulations and is void where prohibited or restricted by law.

**TO ENTER:** Create your Showdown account by visiting NYRA.com/showdown and following the directions to complete and submit the electronic registration form. To enter a Contest, log-in to NYRA.com/showdown using the information provided at time of registration and submit your Contest selections in accordance with these Official Rules. All entries must be received **prior to the first Contest race** to be eligible. Limit one (1) entry per person. Multiple entries from any person will be void. Entries generated by script, macro or other automated or mechanical means or by any means which subvert the entry process are void. All entries become the property of Sponsor.

**TO PLAY:** On each Contest Day, the specific contest format (described below) and races included in the Contest will be published on the America's Day at the Races, Saratoga Live, Belmont Live broadcast (depending on the time of year) and/or at NYRA.com/showdown. Contestants who fail to comply with these Official Rules, including the minimum selection requirements set forth below, will be disqualified and ineligible to receive any prizes. To play, a contestant must log-in to NYRA.com/showdown and make his or her selections in accordance with that day's specific contest format. Each Contest will be conducted in one of the following three contests formats:

- Win/Place/Show Contest. Select one (1) horse for each race included in that day's Contest. By selecting a horse, contestant is placing a mythical \$5.00 bet on the horse selected to Win, Place, or Show.
- Exacta Contest. Select three (3) horses for each race included in that day's Contest.
  By making his or her selections, contestant is placing a mythical \$2.00 Exacta Box bet on the horses selected.
- 3. <u>The Works Contest</u>. Select <u>three (3) horses for each race</u> included in that day's Contest. By making his or her selections, contestant is placing a mythical \$2.00 Win bet

- on each horse selected as well as a mythical \$1.00 Exacta Box bet and a mythical \$0.05 Trifecta Box bet on the three horses selected.
- 4. <u>Series Contest</u>. Select **one (1) horse for each race** included in the day's Contest. By selecting a horse, contestant is placing a mythical \$5 bet on the horse selected to Win. Contest continues each week for a set amount of weeks determined by the rules. Leaderboard will continue to populate with each week's results until the conclusion of the contest.

The number of races included in each Showdown may vary each Contest Day. Please refer to NYRA.com/showdown each day to see which races are included in that day's Contest. Contestants may place their selections only at the Showdown website (NYRA.com/showdown). No selections will be accepted in person, by phone or via e-mail. Contestants may not make more than one (1) selection in each Contest race. The contestant is solely responsible for ensuring that his or her selection is correct. All selections must be made prior to the first Contest race (the "Contest Deadline"). After the Contest Deadline has passed all selections are final and contestants will not be permitted to make any changes. Contestants may review their selections and standings at the Showdown website.

In the event that a contestant's selection is a late scratch (within 10 minutes to post) or declared a non-starter for pari-mutuel wagering purposes, the entrant will receive the actual betting favorite in that respective race. Contestants that select a horse, which is part of a coupled entry or mutuel field, will only receive credit for the horse that is the best finisher out of the coupled entry. For example, if horse 1 and horse 1A finish first and second, respectively, a contestant will only receive credit for a single "Win" for horse 1.

WINNER SELECTION & NOTIFICATION: Potential winners will be determined by contestants' bankrolls after all applicable Contest races have been deemed official by the respective host racetracks. The contestant(s) with the largest total bankroll at the end of each Contest will win the Daily Contest Prize (defined below) up to a maximum of 99 winning contestants. The contestant with the largest single In the event of a tie between two (or more) contestants with respect to a Daily Contest Prize to be awarded, each winning contestant will receive the full prize, up to a maximum of 99 winning contestants. By way of example, if the largest total bankroll at the end of the Contest Day is \$1,000.00 and ten (10) contestants each have a total bankroll of \$1,000.00, Sponsor will award the full Daily Contest Prize to all ten (10) eligible contestants. In the event of a tie for a Daily Contest Prize with 100 or more winning contestants, the following tie-breakers will apply: First, the contestant with the most money earned in a single race during the Contest will be ranked above the others. If a tie still remains after the first tie-break procedure has been exhausted, the final tie-breaker will go to the player with the most money earned in the last race wagered in the Contest. This process will continue until the tie is broken.

Sponsor's decision with respect to winner determination is final and binding. Potential winners will be receive their prize in their NYRA Bets account or be notified by e-mail with instructions on how to claim the prize and must respond to the initial notification within twenty-four (24) hours of that notification. Sponsor will endeavor to reward the potential Daily Contest Prize winners within seventy-two (72) hours of the conclusion of the applicable Contest. If a potential winner does not respond to the initial notification within the time period stated, a prize or prize

notification is returned as undelivered, a potential winner is not available to accept prize, cannot be contacted, or fails to sign and return all required documents within the required time period or is not in compliance with these Official Rules, such potential winner may be disqualified and forfeits the prize. In the event that the potential winner is disqualified for any reason, Sponsor may award the prize to an alternate potential winner in accordance with these Official Rules. Only three (3) alternate winners will be selected for any prize; after which, prize will remain unawarded.

PRIZES & APPROXIMATE RETAIL VALUE ("ARV"): Daily Contest Prize: For Contest formats 1-3, fifty thousand (50,000) NYRA Bets points, which are redeemable, in jurisdictions where available, only for use by NYRA Bets account holders on NYRABets.com. ARV: \$50. If the Daily Contest Prize is not available in the winning contestant's jurisdiction, Sponsor will award a substitute prize of equivalent value at its sole discretion.

PRIZES & APPROXIMATE RETAIL VALUE ("ARV"): Series Contest Prize: For Contest format 4, a grand prize will be distributed to the over-all mythical bankroll leader in the series of two tickets to the 2023 Belmont Stakes Racing Festival (Friday and Saturday event tickets). ARV: \$1,100. If the prize winner cannot personally use the tickets for the Belmont Stakes Racing Festival, they may designate another person to receive the tickets. Tickets cannot be redeemable for cash.

**PUBLICITY GRANT:** Each winner, by acceptance of prize, except where legally prohibited, grants permission for Sponsor and its designees to use his/her name, address (city and state), photograph, voice and/or other likeness and prize information, for advertising, trade and promotional purposes, in any manner, in any and all media now known or hereafter discovered, worldwide in perpetuity, without further compensation or notification to, or permission from, winner.
